Provincial Congress at QE Hotel in Montréal




State officers, regional directors, district deputies, state and regional program officers, and subordinate council officers met at the annual congress held on April 14-16, 2013 at the Queen Elizabeth hotel in Montréal. Several resolutions impacting the Knights of Columbus constitution were passed during the opening plenary session on Friday evening and subsequently forwarded to the supreme council for study. The entire state executive was returned by acclamation during the elections held Saturday morning. A cheque for \$65,000 was also presented to the Crohn's and Colitis Foundation of Canada at the banquet on Saturday evening.

and first joined KofC Council no. 5774 at Most Holy Trinity in Balic-Balic Sampaloc Manila in 1985 and then did his 4th degree in Ferdinand Magellan Province (Philippines district no. 4) in 1989 before becoming active again in 2005 at St. Kevin's and San Lorenzo Ruis assembly no. 3103 of Champlain Province Québec. He is married to Josephine Orcilla and they have 4 children, Mar Raquepo is an accounting graduate, June Raguepo is an engineer, Carmela Raquepo is in business management, and Jonard Raquepo, a first degree knight, is an electronics graduate. Before coming to Canada Bernardo was a general contractor.

Protecting Your Income

Father McGivney faced a major struggle in 1882. How could one determined man in St. Mary's Church possibly keep up with the needs of the families around him, who were under constant stress after losing their breadwinner?

Remember, conditions back then were quite different than they are today. Hard working Catholic men faced long hours in dangerous, unsanitary jobs. Deaths and injuries were common. Catholics were excluded from unions, and faced other discrimination. There were no advocate groups speaking on their behalf, no social welfare programs providing assistance in the case of an emergency. Today, there are laws and organizations, like the Occupational Safety and Health Administration (OSHA) in the U.S. or the Centre for Occupational Health and Safety in Canada, that protect workers from the situations that were prevalent in 1882, and there are programs designed to provide temporary assistance to a family in need, if a tragedy occurs.

While most jobs are safer now, accidents, injuries, and illnesses that can impact your ability to work still happen. Most, in fact, do not happen on the jobsite or place of employment. Did you know that a recent study revealed that more than 95 percent of the longterm disability claims on file were not work related?

The "loss" of the breadwinner does not have to mean that person's death; it can also mean the loss of the breadwinner's income. Consider that loss for a moment. How would your family fare if a source of income suddenly stopped? Could a dual-income family manage on one income stream? What about young families with a working father and a mother who cares for the children? What if his income halted due to an accident or illness?
